

## ASPC/AMHR Futurity Guidelines

The following guidelines are intended to furnish general information to the prospective Futurity participant. Instructions not specifically covered in this writing can be obtained by calling the office at 309 263-4044, asking for the Futurity Dept.

Nominating Forms, as well as Sustaining Forms, will be available Online and in the December Issue of the Journal.

### Who May Enter Into The Futurity?

- You must be a current member of the organization.

### Animal Eligibility.

- Animals must be registered with ASPC/AMHR
- Animals must be within the size limitations. (AMHR 38" & under / ASPC 46" & under)
- Mares must be 3 years old to foal.
- Stallions must be 2 years old to breed.

### Nominations.

- Nomination forms must be completed & submitted by March 1<sup>st</sup>, Super "G" by Apr. 1<sup>st</sup>.
- Foals become eligible if the Sire & Dam were nominated in the Futurity year.
- Stallion Nominating Fee = \$25.00.
- Mare Nominating Fee = \$5.00 for AMHR; \$10.00 for ASPC.  
(The additional \$5.00 for Shetland Mares will be distributed to the Area Futurities)
- A Stallion may breed outside Mares, yet the fee is only paid once.

### Sustaining Procedure.

A foal, whose parents were nominated the prior year, must be sustained as a Yearling, Two Year Old and Three Year Old in order to remain in the Futurity program for the three Year duration. Failure to sustain the animal in any year will eliminate its eligibility.

Due date is March 1<sup>st</sup>.

- Yearling Sustaining Fee = \$10.00
- Two Year Old Sustaining Fee = \$10.00
- Three Year Old Sustaining Fee = \$20.00
- All Sustaining years can be prepaid if so desired.

### Class Entry Fees.

Class entry fees are only paid if the animal is entered into a class. Failure to enter in a particular year DOES NOT eliminate the animal from showing the next year, provided the animal has been sustained on a continued basis.

Entry fees become part of the monetary distribution in their entirety each year.

### Classes And Divisions.

- Miniatures 34" & under are shown in the "A" Division.
- Miniatures over 34" to 38" are shown in the "B" Division.
- Foals are shown in separate classes. (Stall./Geld. & Fillies) – AMHR & ASPC.
- ASPC Yearlings & Two Year Olds have separate classes for Classic, Foundation, Modern & Modern Pleasure.
- Three Year Olds are split by sex in Halter, shown together in Performance. – AMHR
- Three Year Olds may show in Halter and either Pleas. Driving or Roadster. – AMHR
- Three Year Olds (Modern Shetland) can show in either Harness, Roadster or Pleas. Driv.-ASPC
- Three Year Olds (Classic Shetland) are shown in Pleasure Driving only. – ASPC

## Winning Distribution

### AMHR:

#### Original Nomination Payout Calculation

Foals=15%; Yearling=25%; 2 Year Old=25%; 3 Year Old=35%.

#### Yearling Sustaining Fee Distribution

Yearling=30%; 2 Year Old=30%; 3 Year Old=40%.

#### Two Year Old Sustaining Fee Distribution

2 Year Old=40%; 3 Year Old=60%.

#### Three Year Old Sustaining Fee Distribution

3 Year Old=100%.

#### Class Winnings Distribution

One in Class=100%; Two=57%-43%; Three=46%-32%-22%; Four=40%-30%-20%-10%;  
Five=37%-27%-17%-12%-7%.

### ASPC – Classic:

#### Original Nomination Payout Calculation

Foals=20%; Yearling=30%; 2 Year Old=30%; 3 Year Old=20%.

#### Yearling Sustaining Fee Distribution

Yearling=30%; 2 Year Old=30%; 3 Year Old=40%.

#### Two Year Old Sustaining Fee Distribution

2 Year Old=40%; 3 Year Old=60%.

#### Three Year Old Sustaining Fee Distribution

3 Year Old 100%.

#### Class Winnings Distribution

One in Class=100%; Two=57%-43%; Three=46%-32%-22%; Four=40%-30%-20%-10%;  
Five=38%-28%-18%-10%-6%.

### ASPC – Modern:

#### Original Nomination Payout Calculation

Foals=15%; Yearling=25%; 2 Year Old=25%; 3 Year Old=35.

#### Sustaining Fee Distribution

Yearling=30%; 2 Year Old=30%; 3 Year Old=40%.

#### Two Year Old Sustaining Fee Distribution

2 Year Old=40%; 3 Year Old=60%.

#### Three Year Old Sustaining Fee Distribution

3 Year Old=100%.

### **Class Winnings Distribution**

**One in Class=100%; Two=57%-43%; Three=46%-32%-22%; Four=40%-30%-20%-10%;  
Five=38%-28%-18%-10%-6%.**

**Added to the above monetary distribution of Nominating and Sustaining fees will be the total Class Entry amount plus the portion contributed by the Club. Presently this amount is \$17000.00, which will be evenly disbursed to the animals showing in the Futurity and placing according to present rules.**

### **AMHR Super “G” Futurity – Rules & Guidelines**

#### **Who May Enter Into The Super “G” Program?**

- You must be a current member of the organization.

#### **Animal Eligibility.**

- All Colts in the AMHR Futurity (Yearling Colts) are eligible.

#### **Fee Structure.**

- A \$25.00 payment is due April 1, to make your Colt eligible.
- A \$100.00 payment is due April 1, to sustain your Two Year Old Colt.
- A \$100.00 payment is due April 1, to sustain your Three Old Colt.  
(This horse must be gelded by the time he is to show in the Three Year Old Super “G’ Futurity Class)

#### **Showing Rules & Regulations.**

- There are 4 Super “G” Futurity Classes, Division A and B.
- Horse may be shown in either Halter or Pleasure Driving – NOT BOTH.
- The program eligibility is transferable to new owners.
- Late buy-in fees are double the regular fee for the year omitted.
- A late buy-in provision does not exist for the regular Futurity Program.
