## INSTRUCTIONS FOR COMPLETING REGISTRATION APPLICATION

**APPLICANT PLEASE NOTE – You are COMPLETELY RESPONSIBLE for the information submitted on this application. If there is ever a question about the age of this animal, you must agree to have said animal inspected and/or mouthed to verify its age. Remember – The information contained on this application will be used as documentation for the registration certificate. BE SURE YOU ARE CORRECT on the spelling of all names, registration numbers, the complete foaling date, and the accurate description of the animal.**

1. **FEE -- \$25.00 U.S. Dollars**
2. **ELIGIBILITY – The National Show Pony Registry will be open to any pony 14.2 hands and under that can be verified by DNA that one parent is registered in either ASPC or AMHR. DNA will be required of qualifying parent and offspring to be registered. DNA Request form available through the ASPC/AMHR/ASPR/NSPR or from the website ([www.shetlandminiature.com](http://www.shetlandminiature.com)) Forms On Line.**
3. **HEIGHT – All American Show Ponies must meet the height requirements as follows:**
  - A. **The maximum overall exhibition height must be 14.2 hands or less.**
  - B. **The measurement is to be from the highest point of the withers.**
4. **SIGNATURE OF OWNER – Owner, or owner’s authorized agent must sign the application. Owner Signature Card must be on file with the NSPR office.**
5. **FOALING DATE – Give month, day, and year. There shall be no age limit set for registration of a pony into the National Show Pony Registry.**
6. **NAME OF ANIMAL – Two name choices are requested in case one name has already been taken. Names cannot have more than Twenty-nine (29) letters, including spaces and punctuation.**
7. **SEX – State whether the pony is a STALLION, MARE, OR GELDING (include gelding date).**
8. **NAME AND NUMBER OF QUALIFYING PARENT – Give COMPLETE name of qualifying registered sire OR dam and the registration number.**
9. **COLOR – Please be specific. “Dapple”, “Roan” or “Appaloosa” alone cannot be accepted as color.**
10. **Submit 4 current photographs of the animal (1) Full profile/side view of left side; (2) Full profile/side view of right side; (3) Full facing forward frontal view; and (4) Full rear view. All four legs must be seen from both sides; markings on face must be visible. All photos should include all parts of the animal available in that view (ears to hooves or nose to tail inclusive) and be unobstructed by any other object or animal. Photos must be a minimum of 3” X 3”. Scanned, digital or computer generated photos, if they are received on photographic paper, are acceptable. Additional photos should be submitted to verify markings not seen in the standard four photos (i.e., white on belly, markings under mane area, etc). It is advisable to label each photo with first choice of pony name and owner’s name. All photos will be kept on file.**
11. **STALLION REPORTS or SERVICE CERTIFICATES are not required to be filled out in order to register an NSPR animal; these are performance only and not breeding animals. NSPR bred to NSPR is not eligible for registration.**

As long as the qualifying parent meets the DNA & Registry requirements, the second parent does not need to meet any requirement. A NSPR registered animal will be able to compete in 3 Divisions (Carriage, Western and Hunter).
