**Add: Renamed, "Classic Carriage Pleasure Driving," Add, A Pleasure class to be judged 60% on manners, quality and performance 40% on conformation.... shown at a walk, slow trot and working trot, both ways of the ring, to line up and stand quietly.** Classic Carriage Stakes Class will be judged as a Classic Carriage Pleasure Driving class.

**Delete: Remove, Classic Carriage Driving, Remove** The Classic Carriage Driving class will be divided into two (2) separate driving divisions. A Single Pony Carriage Turnout class and a Multiple Pony Carriage Turnout class for the ASPC/ASPR Congress and the split will be optional for all Local and Area shows.

**Rule Proposal**

1. **Classic Carriage Pleasure Driving: "A Pleasure class to be judged 60% on manners, quality and performance 40% on conformation. To be shown at a walk, slow trot and working trot, both ways of the ring, to line up and stand quietly.** It is not a requirement to back in this class. Classic Carriage Stakes Class will be judged as a Classic Carriage Pleasure Driving class.

**Justification:**

This clarification of the rule will provide more structure and understanding for the participants and judges on the requirements of this carriage class.
