## Section 11, Article 4.7, Part ~~D~~, # 3

**Add: For number for replace wording with working trot to strong trot. Add a number 8, which if the other rules changes go through would be number 7. A pattern or workout must be administered at the AMHR National Show.**

**Delete: Remove pleasure trot and extended trot.**

**Remove all wording in number four and five.**

### **Rule Proposal:**

**3. Classic Carriage Reinsmanship:** This class is designed to test the knowledge and ability of the driver. To be shown on the rail at a walk, slow trot and working trot. To be judged primarily on the ability and skill of the driver. To be **judged 75% on the handling of the reins and whip, control, posture and overall appearance of the driver and 25% on the condition of the harness and vehicle and the neatness of attire.**

In order to evaluate a driver's versatility, the judge may require a test.

#### a. Suggested Tests:

1. Back.
2. Drive a circle of designated size, at judge's discretion.
3. Drive a figure eight.
4. ~~Extended trot intermediate gait.~~ Working trot to Strong Trot.
5. ~~Negotiate simple obstacles, e.g. drive between two obstacles.~~
6. Stop and stand.
7. Drive with one hand.
8. **A pattern or workout must be administered at the AMHR National Show.**

### **Justification:**

This gives more specific instruction to the judges and participates for what the class should be judged on. With the suggested tests, we are trying to make it easier to not need an aid. We must show a pattern or workout at Congress and National show to set a standard for the local shows as well as competency.

Rule Proposal:

**4. AMHR Carriage-Working:** A class in which entries are judged primarily on the suitability of the pony to provide a pleasant drive. **To be shown both ways of the arena at a walk, slow trot, working trot, and strong trot. To stand quietly, both on the rail and while lined up, and to rein back.** All entries chosen for a workout may be worked both ways of the arena at any gait requested by the judge and may be asked to execute a figure of eight. A workout will be under the discretion of the judge. **To be judged 70% on performance, manners and way of going of the pony or ponies, 20% on the condition and fit of harness and vehicle, and 10% on neatness of attire. An entry must show strong definition in all required gates.**

Justification:

This word change will provide clarity on the class requirements for the participants and judges. It further defines what the working class is being judge on.

Bridles should fit snugly to prevent catching on the vehicle or other pieces of harness. A throatlatch and a noseband or cavesson is mandatory. Open bridles are permitted, but are not encouraged.

**Justification:**

Breeching should be required for all vehicles for safety reasons. Breeching is the breaking mechanism for most carriage vehicles. It is for the safety of the ponies and exhibitors to add this rule change.

Rule Proposal:

**4. Classic Carriage-Working:** A class in which entries are judged primarily on the suitability of the pony to provide a pleasant drive. **To be shown both ways of the arena at a walk, slow trot, working trot, and strong trot. To stand quietly, both on the rail and while lined up, and to rein back.** All entries chosen for a workout may be worked both ways of the arena at any gait requested by the judge and may be asked to execute a figure of eight. A workout will be under the discretion of the judge. **To be judged 70% on performance, manners and way of going of the pony or ponies, 20% on the condition and fit of harness and vehicle, and 10% on neatness of attire. An entry must show strong definition in all required gates.**

Justification:

This word change will provide clarity on the class requirements for the participants and judges. It further defines what the working class is being judge on.
