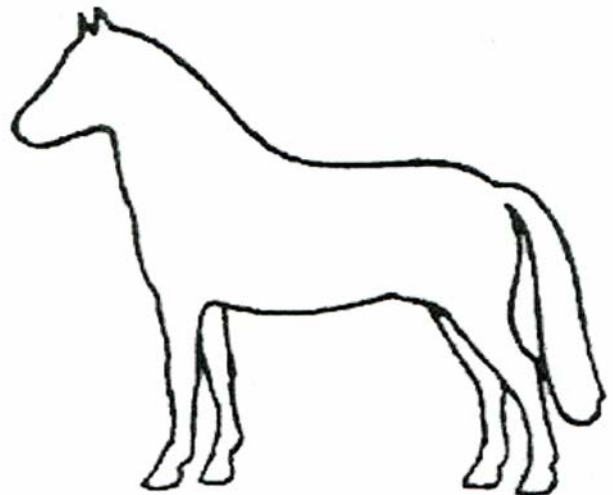
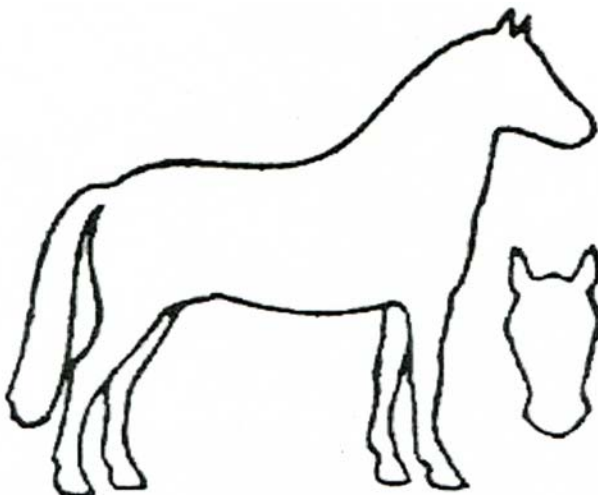

INSTRUCTIONS FOR COMPLETING REGISTRATION APPLICATION

APPLICANT PLEASE NOTE – By your signature on this registration application, you are certifying that the information submitted on this document is true and correct to your knowledge and that you agree to abide by the rules set forth by the ASPC/AMHR/ASPR. If there is ever a question about the age of this animal, you must agree to have said animal inspected and/or mouthed to verify its age.

Remember – The information contained on this application will be used as documentation for the registration certificate. **BE SURE YOU ARE CORRECT** on the spelling of all names, registration numbers, foaling date, and accurate description/markings of the animal.

1. **Name of owner(s) – Current owner of Dam at time of foaling.**
 The signature of owner or authorized agent must be the person(s) who owned the dam at the time of foaling. To sign as an “authorized agent”, your name must be on record as such in the ASPC office. It is suggested that all members have an Owner Signature Card on file in the National office.
2. **FOALING DATE – Month, day and year required.**
 All Shetlands registered by December 31st of their yearling year do not require DNA. All two year old and older Shetlands may be registered with DNA testing of the individual as well as the sire and dam. Stallion report must be on file in home office.
3. **NAME OF ANIMAL – Two name choices are required as some selections are in use or cannot be used. Names are limited to thirty-five (35) letters, spaces or punctuation.**
4. **SEX – You must circle the gender, either STALLION, MARE, OR GELDING. Gelding Certification form MUST accompany registration application if being registered as such.**
5. **NAME AND NUMBER OF SIRE AND DAM – Give COMPLETE name of sire and dam and the registration numbers.**
6. **COLOR – Please be specific. “Dapple” or “Roan” alone cannot be accepted as color. Appaloosa is not acceptable.**
7. **BREEDER – Owner of the dam at the time of service.**
8. **If you wish photos to be incorporated onto the front of your certificate, you must submit 4 photographs of the animal; a full frontal, a full rear, a right side and a left side, one of which has the horse’s head turned toward the camera so the front of the face can be seen. You must be able to see the entire horse; no ears, hooves, nose or tail can be missing from the photos. If you are not providing photos, then you **MUST RECORD AND DRAW THE MARKINGS** on the template on the front of this form or your work will have to be returned.**
9. **SERVICE CERTIFICATE – Must accompany all registration applications if the owner of the dam did not own the stallion at the time of service. Service certificates are available from the ASPC office or website at www.shetlandminiature.com.**
10. **STALLION REPORTS – Must be filed by January 15th following each breeding season. Dam must be listed on the stallion’s service report in order to register an offspring.**
