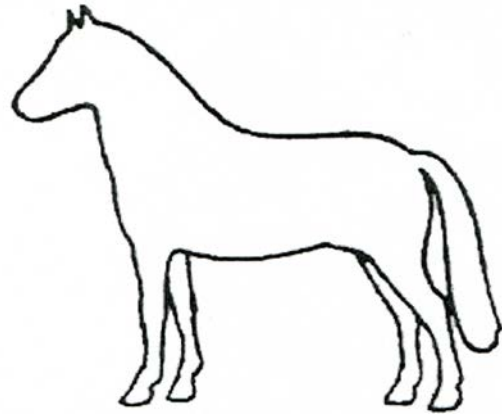
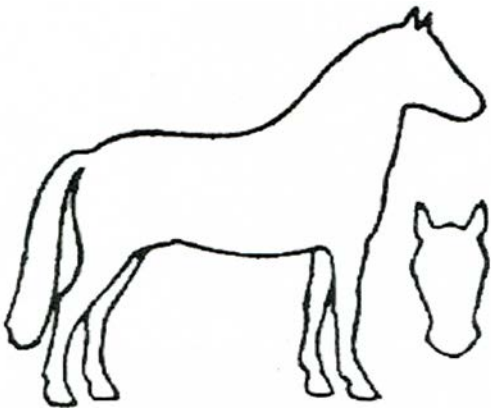

(3) Full facing forward frontal view, and (4) Full rear view. All four legs must be seen from both sides; markings on face must be visible on one side photo.**

## **INSTRUCTIONS FOR TRANSFER OF OWNERSHIP**

1. Fee is \$15.00 for a sale date six months old or less, \$25.00 for transfers over six months.
2. Each transfer form must be completely filled out by the seller or authorized agent in his own handwriting.
3. Please PRINT all required information.
4. If certificate is to be forwarded to anyone other than the member submitting the work, the registry office **MUST BE NOTIFIED IN WRITING.**
