# Section XVIII, Page 335

Judges: Must be ASPC/AMHR/ASPR carded. National Area shows may use one (1) Judge for the Miniatures and one (1) Judge for the Shetlands, but may choose to use only one (1) Judge for the entire show if the show is not so large as to put undue stress on one (1) Judge. A National Area Show will count as three (3) Judges toward qualifying for the AMHR National Show. Apprentice judges are not allowed at National Area Shows, except for designated Area shows that allow Modern apprentices outside the ring. No Nationals or Congress Judge can judge more than one National Area Show in the same year. Passed at convention 43 – 0. Alan Dial motioned to accept rule change. Donna Phillips seconded. #### Foundation

In addition to the current process, alternately the resulting foal of a mating of one ASPC registered foundation sealed parent to a non-sealed ASPC registered parent may be

"FOUNDATION TYPE CERTIFIED" after the pony's actual third birthday. A pony submitted for "Foundation Type Certified" must be 42 inches or under. The pony must possess the correct body type according to the rulebook foundation standard. To Foundation Type Certify, the applicant must provide a Foundation Type Certification application, a measurement card taken within the last 60 days, a copy of the ponies current Shetland registration paper and the non-refundable evaluation fee to the National ASPC Office. The measurement card must be completed, the pony measured by an ASPC licensed steward and witnessed/signed by a carded ASPC/AMHR judge. Three randomly selected volunteer judges, from a list determined by the Foundation Committee, will examine the candidates in person. Each judge will complete an evaluation of the pony to determine if the pony meets the foundation standard. These evaluations will be used by the ASPC National office to determine the outcome. Two of the three judges must concur that the pony meets type to grant the Certification. If the outcome is positive, the member submits the notification, measurement card, the appropriate registration fee and the pony's current registration certificate to the ASPC National office for the creation of a sealed registration certificate.
