Other than as set forth above, neither The American Shetland Pony Club, nor any of its directors, officers, employees, committee members, representatives or agents shall be liable in any event for any action or failure to act in connection with the operation of the Registries maintained by the Corporation.

1. Any Registry record found to be inaccurate may be expunged or altered as deemed appropriate by the Director of Operations or the Board of Directors.
2. If any statement in any registration or transfer application should at any time be found to be inaccurate, the registration or transfer may be omitted from publication or published in altered form. If any error published information should be discovered after publication, the correction may be made and published in such form as the Director of Operations or Board of Directors may determine.
