Presentation of signed entry blanks shall be deemed acceptance of these rules and in the event of failure to sign the entry blank, the first entry into the show ring as an exhibitor shall be deemed to be the acceptance of rules. **No Refunds on Stalls at any time!** Notice must be received in the home office no later than June 30, 2025 for an entry fee only. The entry fee in this case will be refunded, less an office fee of \$50.00.
