# **FOUNDATION HARDSHIP APPLICATION PACKET**

The ASPC will Foundation seal an ASPC registered animal provided all fees, application work, Foundation Height Verification, and Inspection Forms are complete. All animals considered for Foundation Seal must have reached their actual 3rd birthday before official measurement can be done. Animal identified on this form cannot show in ASPC Foundation classes until the National office issues a Foundation number.

### **Qualifications:**

Animal must have reached it's actual 3rd birthday.

Animal must measure 42" or under at the withers.

The owner must submit the \$100 application fee to the National office.

Animal must be measured by one (1) ASPC/AMHR Steward and witnessed by any ASPC/AMHR licensed judge. The Height Verification form is to be submitted to the National office by the Steward.

Animal must be inspected by three (3) individuals from the Foundation Evaluators List. Each Evaluator is responsible for submitting the forms to the National office.

If the animal receives two (2) "Meets" the standard evaluations, a third is not necessary.

Steward and Evaluators chosen may not be related to the owner or trainer of the animal.

One parent of animal must have a Foundation seal.
