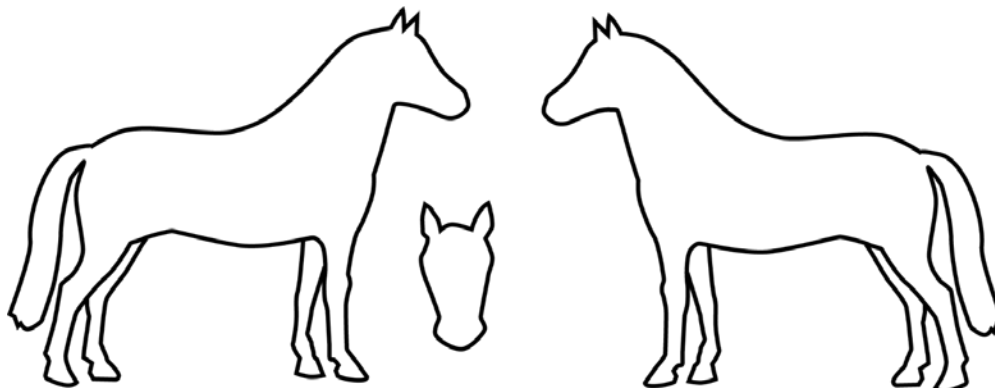

## Instructions for Completing Registration Application

PLEASE NOTE: By your signature on this registration application, you are certifying that the information submitted on this document is true and correct to your knowledge and that you agree to abide by the rules set forth by the ASPC/AMHR/ASPR. If there is ever a question about the age of this animal, you must agree to have said animal inspected and/or mouthed to verify its age.

**REMEMBER:** The information contained on this application will be used as documentation for the registration certificate. BE SURE YOU ARE CORRECT on the spelling of all Names, Registration Numbers, Foaling Date, and description/markings of the animal.

**ELIGIBILITY REQUIREMENTS:** - The National Sport Performance Pony Registry will be open to any pony 14.2 hands and under and one parent that is registered either ASPC or AMHR. Horses/ponies born after Jan. 1, 2012, do not have to be parent qualified ONLY IF a 2011 or later stallion report is on file in the National Office listing the dam. DNA forms to submit to the U of KY are available from the home office or website: [www.shetlandminiature.com](http://www.shetlandminiature.com). We will also accept DNA reports from UC Davis and Equine Genetics, Inc.

**HEIGHT** – All National Sport Performance Ponies must meet the height requirements:

- A. The maximum overall exhibition height must be 14.2 hands or less.
- B. The measurement is to be from the highest point of the withers.

### CHECK YOUR APPLICATION TO AVOID WORK BEING RETURNED.

- Name of Owner(s):** Current owner of Dam at time of foaling.  
The signature of owner or authorized agent must be the person(s) who owned the dam at the time of foaling. To sign as an “authorized agent”, your name must be on record as such in the national office. It is suggested that all members have an Owner Signature Card on file at the national office in Morton, IL
- Foaling Date:** Month, Day and Year are Required  
All Shetlands registered by December 31<sup>st</sup> of their yearling year DO NOT require DNA. **All 2 Year Old and Older Shetlands** may be registered with DNA testing of the animal as well as the sire and dam. Stallion report must be on file in the national office.
- Name Animal:** Two name choices are required as some selections are in use or cannot be used. Names are limited to thirty five (35) characters – this includes letters, spaces and punctuation.
- SEX:** You must check the gender, either Stallion, Mare or Gelding. Gelding Certification form **MUST** accompany registration application if being registered as such.
- Name and Number of Qualifying Parent:** Give COMPLETE name of sire and/or dam and the registration numbers.
- Color:** Please be specific. “Dapple”, Roan” or “Appaloosa” alone cannot be accepted as a color.
- Breeder:** Owner of the dam at the time of service.
- Markings:** If you wish photos to be incorporated on to the front of your certificate (preferred), **you must submit four (4) photographs** of the animal: a full frontal (front of face in clear view), a full rear, a full right side and a full left side. One side view must include a full front view of face (head turned toward the camera). Images must include the entire horse in the image – if ears, hooves, nose or tail are not completely included in the image, it is not acceptable.  
**If you are not providing photos, you MUST** record and draw the markings on the template on the front of this form or your work will be returned.
